STANDING FOR RE-ELECTION: MARION ATKINSON (Chair, Women in Community Rail)

Proposer – Sheila Davidson, Membership Secretary, Women in Community Rail *Seconder* – Richard Lysons, Board member, Women in Community Rail

I have been involved in community rail since the early 2000's whereby I brought the concept of station adoption into the Liverpool City Region. I am currently employed as a rail support officer at Merseytravel and have worked in local government for 30+ years.

I have served as a board member on Community Rail Network for a number of years and was elected as Vice Chair approximately five years ago. I was also Chair of the award winning West Lancashire Partnership for 12 years until 2021 and also took the Cambriam line out of special measures.

I currently Chair *Women in Community Rail (WiCR)* and support members of WiCR with training, advice, guidance, whilst promoting inclusion and diversity to improve representation within community rail. I led on the introduction of the code of conduct which now forms part of the designation process recognised by DfT.

My skill set includes the ability to respectfully challenge, political awareness, good communication including listening and interpersonal skills whilst also being able to make effective decisions. I promote collaborative working and strive for an inclusive and tolerant community rail family which I believe we have made lots of progress, but there is still more to do.

I am also the first female leader of Sefton Council and work to promote inclusion and diversity in public life.

As a voluntary Director of SCRP, and volunteer Chair of Crowborough Community Hub, which is creating a community space for the community by the community in the disused part of Crowborough train station, I have a great interest in the work of CRN. I have worked for Severnside Community Rail Partnership (SCRP) for 10 years, developing a passion for Community Rail and advocating for the impact it makes. In my previous role as Creative Programme Lead for a city-wide youth charity, I greatly valued the opportunity to collaborate closely with the board of trustees, and I am eager to bring that constructive experience to the Community Rail Network (CRN) board.

As a Community Development Officer working across a broad geographic area and demographic of communities, I understand the sensitivity and diplomacy required to communicate ideas and make progress, as well as the importance of bridging the gaps between our communities and the rail industry. A key part of my role is looking for opportunities for partnership working, funding and development beyond the industry. These are all skills I would like to bring to the board.

STANDING FOR ELECTION: NEIL SCOTT (Chair, Cambrian Railway Partnership)

The role of a Director of Community Rail Network requires someone with passion, insight and vision to help CRN develop its strategic goals.

As a Director I would leverage my managerial and leadership experiences for the benefit of Community Rail Network and offer my knowledge of chairing and developing the Cambrian Railway Partnership as an example of my commitment and expertise in acting in a senior and strategic role.
